Cook Islands

Rarotonga Monarch conservation effort

The population of the Rarotonga Monarch (*Pomarea dimidiata*) once one of the world's rarest birds, is on the rebound thanks to intensive conservation action, particularly through the control of invasive alien predators like black rats. An estimated 380 individuals is recorded, which is over ten times larger than at its low point. Conservation efforts are still needed to keep the population healthy. Funds to fight coffee berry borer

More than \$500,000 has been targeted for efforts to fight the coffee berry borer on the Big Island. The pest, which was discovered on the island in 2010, is now responsible for the damage or destruction of up to 50 percent of some farmers' coffee yields in the Kona and Ka'u regions. The money will partly be used to treat farms with a fungus that has been shown to be effective in controlling the berry borers. Read more about coffee berry borer...

2nd Mongoose sighting

Staff of the Ministry of Natural Resources and Environment quickly deployed traps in the Aleipata district after a sighting of a mongoose was reported by a villager. Fear that another mongoose may be on the loose comes not long after a mongoose was removed from the same area in 2009. Despite weeks of trapping and survey there is no sign of the mongoose and no more reporting from the public. Pacific Invasives Partnership (PIP) - news

The Pacific Invasives Partnership annual planning meeting

The Pacific Invasives Partnership held its annual planning meeting from 18-20th June at the IUCN-Oceania office in Suva, Fiji. The meeting was chaired by Dr Souad Boudjelas who was elected for another term as the PIP chair. The meeting allowed the partners to review the 2011-2012 work-plan and to develop its 2012-2013 plan. Thirteen participants attended the meeting with additional members joining via skype. Some of the key outcomes from the meeting include:

- Draft 2012-2013 Workplan to be finalized electronic and circulated to all members
- Draft Communication Strategy to be completed and an Action Plan to be developed
- Completion of a communication paper for the upcoming Pacific Islands Forum Leaders meeting in the Cook Islands
- PIP response and preparation for upcoming events including the World Conservation Congress (Korea), the pre-COP 11 and NBSAP review (Rotorua), the SPREP Meeting (Noumea, New Caledonia) and CBD COP 11 (Hyderabad, India). A roadmap will be developed for some of these events for invasive species events.

Invasive news global

Australian invasive species taskforce needed

The Australian Government must stem the rising tide of environmental pests by creating a national body tasked with harnessing the energy and brainpower of community volunteers already battling the nation's escalating weed and feral animal crisis, the <u>Invasive Species Council</u> said today.

Myrtle rust slipped through biosecurity borders

The pathogen, myrtle rust, had slipped through national biosecurity borders and has since spread to far north Queensland and Victoria. Climatic modelling suggests it will spread much further. There are more than 2000 plants in family Myrtaceae, Australia's dominant plant family, including eucalypts, bottlebrushes and tea trees - most are susceptible to the disease. Myrtle rust could alter the composition and function of forest, woodland, heath and wetland ecosystems. This incursion is about as bad as it can get for biosecurity in Australia – a new disease attacking our dominant plants, including species already on threatened lists. Read more on Myrtle Rust...
